- Perform/Supervise tasks related to the installation, testing, & operation of natural gas facilities including:
 - Installation of distribution mains & services
 - o Installation of transmission pipelines & facilities
 - Leakage surveys & leak investigations
 - Cathodic Protection (CP) surveys & remedial actions
 - Hot tapping of mains, services, & transmission lines utilizing Mueller equipment
 - Pressure testing facilities using inert gas, air or water
 - o Atmospheric corrosion remediation
 - Odorization equipment installation, maintenance & testing
 - o Regulator station inspections
- Own and manage processes, and lead direct reports, subcontractors, and consultants to desired outcomes.
- Strong interpersonal skills, flexibility, and customer service orientation.
- Understand and adhere to all commercial and contractual obligations
- Ability to prepare routine administrative tasks and timely submission of electronic reports.
- Maintain familiarity with steel welding procedures to evaluate quality to meet company standards.
